Introduction

Purpose and Scope

Texas State Publications is a monthly checklist intended for use as a reference source, current-awareness tool, and acquisition aid to the publications produced and distributed by Texas state agencies, institutions of higher education, and other organizations that are affiliated with, or operate under the aegis of, the state government. The checklist traces, at least in part, the publishing activities of the Texas government. The checklist announces the monographs, serials, new periodical titles and ephemeral materials that are deposited with the Texas State Library and Archives Commission and processed by the Texas State Publications Depository Program.

Publications usually excluded from this list are: (1) materials exempt from the Depository Program, such as: agendas, advertisements, alumni materials, announcements, artwork, calendars, complex relational databases, contracts, correspondence, course schedules, departmental curriculum catalogs, drafts, fiction, forms and instruction manuals for their completion, fund-raising materials, grant proposals and bids, hearings transcripts, job listings, literary criticism, memorabilia, memoranda, news or press releases, newsletters for internal use only, notices of sale, opinions and orders of state courts, daily or weekly periodicals, personnel manuals, photographs, poetry, policy handbooks for internal use only, recruitment materials, reprints, stationery, student publications, telephone directories for internal use only, and volunteer newsletters; (2) other types of publications that represent works-in-progress that will be compiled into other publications, such as bills, daily legislative journals, slip laws, opinions and resolutions; and (3) individual issues of periodicals. Also excluded are retrospective materials that were published more than five years prior to the current issue of the checklist.

Arrangement

Agencies that contribute to the checklist include state agencies, departments, state-federal cooperating agencies, regional governmental bodies, as well as state colleges, universities and other institutions of higher education or research. The checklist arranges publications by issuing agency, alphabetically by the key word in the agency's name. For example, look for materials from the Attorney General, the Department of State Health Services, or the Texas Youth Commission in the alphabetical sections for 'A', 'H' or 'Y', respectively. Subdivisions of agencies occasionally are given separate headings (e.g. the Property Tax Division of the Comptroller of Public Accounts appears following the heading for the parent agency). Publications issued by state colleges, universities and their affiliated institutions are grouped together *following* the agency listings, under the entity's official name without regard to key word.

Bibliographic Details

Each entry contains the following information when available or applicable: 1) entry number; 2) title and statement of responsibility; 3) edition; 4) date of publication or first issue; 5) pagination; 6) frequency; 7) OCLC record number; 8) distribution symbol; 9) microfiche availability symbol; and 10) Texas document classification number. Ephemeral materials not needing full bibliographic description appear at the end of the publishing entity's entry, in an alphabetical-by-title list under the subheading "LEAFLETS."

Subject Access

Beginning with the January 2007 issue, *Texas State Publications* no longer includes a subject index. The cataloged materials announced here are represented in two widely-available on-line resources, OCLC and the Library Catalog of Texas State Agencies. The latter resource is available for free on the Internet at www.tsl.state.tx.us/catalog. The on-line catalog provides various means to search for materials, including the Library of Congress subject headings. Searching the on-line catalog provides comprehensive bibliographic access to all materials announced here as well as to the majority of the Texas documents collection at the Texas State Library.

Distribution of Materials in Physical Format

Whenever possible, the Depository Program sends copies of the publications it receives to its depository libraries, thereby enabling citizens to have ready access to Texas state publications in their local areas. To determine whether a publication has been distributed, note the distribution symbol given with each entry. The distribution symbols are: **(D)** Depository: the publication is available for loan from the Texas State Library and all state depository libraries; and **(N)** Non-depository: the publication is available for use at the Texas State Library.

Availability of Materials in Physical Format

The Texas State Library has available, for library patron use, single copies of the all publications listed. Publications showing depository distribution (D) are also available from state depository libraries. Many non-depository (N) publications can be obtained by local libraries through the state's interlibrary loan system. *Requests for permanent copies must be directed to the issuing agency.* Inclusion of a title on the checklist does not guarantee that an agency has copies available for general distribution.

Directory Information for Publishing Entities

Prior to the January 2007 issue, the checklist provided agency address and telephone information; however, the Depository Program is discontinuing this practice. Texas state government organizations, almost without exception, have established a web presence on the Internet; conducting an on-line query at any common search engine index usually retrieves a site for a known entity. Most state agencies in the Austin area appear in the *Capitol Complex Telephone System (CCTS) Directory*, available on the Internet; visit www.dir.state.tx.us/ccts/directory/index.html to identify contact information for Austin agencies. If an agency or other institution proves especially difficult to locate, researchers may contact the Depository Program by telephone at 512-463-5434 or by e-mail at statepubs@tsl.state.tx.us for assistance.

Electronic Publications

As part of its legislative mandate to index all state publications that are available through the Internet, the Texas State Library has established the Texas Records and Information Locator (TRAIL). TRAIL identifies electronic publications by regularly visiting Texas government web sites and creating a full-text index of all pages that are publicly-accessible. In addition, as TRAIL encounters web resources it downloads a copy of each file and stores it in an electronic archive for future access. In this way, TRAIL fulfills the role of preserving electronic state publications in a manner similar to the steps taken by the Depository Program for publications in physical formats. Micropublishing Program

With some exceptions, most (N) Non-depository publications can be purchased in microfiche format from the State and Local Records Management Division of the Texas State Library. The microfiche availability symbol (i.e. MF = Y), that is displayed with each entry indicates whether a publication has been selected for conversion to a microfiche format. Microfiche copies of a publication can be purchased for a reasonable cost.
