**Evaluation Methods Used:** Evaluation of the product involved a combination of manual and functional testing with assistive technology across multiple platforms and browsers, against the applicable success criteria in Web Content Accessibility Guidelines (WCAG) 2.2 Conformance Level A & AA, Section 508, and EN 301 549.

Adding audio description to such a resource would risk either redundancy to what the illustrator is saying, or a view of the work that is not the illustrator's, the latter of which is contrary to the TeachingBooks.net philosophy of allowing book creators to speak for themselves. TeachingBooks' audio is often authors and illustrators describing their work, and sounds or images other than the spoken word rarely exist. Also note that TeachingBooks embeds videos from a wide variety of sources and includes captions and descriptions as provided by the producer.
